

The parties hereby agree that PIX will act as representative for the PHOTOGRAPHER in handling his work for the above account, from which PHOTOGRAPHER had no assignments before being assigned for that customer by PIX.

The customer is protected for PIX starting with the first assignment given to the PHOTOGRAPHER by PIX for that particular account.

PIX will be entitled to a commission of 50% of all the amounts received by PIX or PHOTOGRAPHER for work done for protected accounts for a period of six months following the date of the last assignment from that client.
