ITEMS ON THIS BANK NOT FOUND GOOD AT CLOSE OF BUSINESS ON DAY OF DEPOSIT WILL BE CHARGED TO DEPOSITOR. THIS BANK WILL USE DUE DILIGENCE IN SECURING RESPONSIBLE COLLECTING AGENTS BUT WILL NOT BE RESPONSIBLE FOR THEIR ACTS OR OMISSIONS, NEGLIGENT OR OTHERWISE, AND ALL SUCH AGENTS, WHETHER DIRECT OR INDIRECT, SHALL BE DEEMED AGENTS OF THE DEPOSITOR AND NOT AGENTS OF THIS BANK.
