AT PRESENT, SHE IS IN A HOSPITAL IN MASSACHUSETTS BUT WE HOPE TO HEAR FROM HER WITHIN A FEW DAYS. SHE MAY HAVE PUT THE NEGATIVES AND ENLARGEMENTS IN A DRAWER AND WE DON'T KNOW WHERE.

AGAIN I CAN ASSURE YOU THAT WE NOT ONLY REGRET IT EXTREMELY BUT WE ARE SURE THAT THEY WILL TURN UP IN THE VERY NEAR FUTURE.

YOU WILL REMEMBER THAT YOUR NEGATIVES WERE SENT TO US ON MARCH 30, THEREFORE ARRIVED HERE AROUND APRIL 2. ON APRIL 4, I CHECKED WITH LARRY WILLIAMS OF HOLIDAY, THE PICTURE EDITOR, AS TO WHETHER HE WOULD BE INTERESTED IN YOUR STORY AND, IF HE WAS, WE WOULD MAKE ENLARGEMENTS AND SEND THEM TO HIM. OVER THE PHONE HE SAID HE WAS NOT INTERESTED FOR THE TIME BEING.

HOWEVER, I KNOW DEFINITELY THAT WE MADE ENLARGEMENTS OF ALL 4x5 NEGATIVES AND CONTACT PRINTS ON THE 5x7'S HERE IN OUR OFFICE, WE DID NOT SEND THEM OUT TO ANYBODY.

YOU MIGHT ALSO BE INTERESTED IN KNOWING THAT LARRY WILLIAMS HAS JUST TOLD ME THAT THERE IS A POSSIBILITY THAT THEY MAY BE INTERESTED IN THE SUBJECT SINCE THEY ARE PLANNING AN ARTICLE ON CHICHEN ITZA. WE ARE CONTINUING OUR SEARCH FOR THE NEGATIVES AND ENLARGEMENTS AND YOU SHALL HEAR FROM US AS SOON AS THERE IS A RESULT.
