Dear Miss Gilpin:

Thank you very much for your letter and order of December 12 and for your enclosed check in the amount of \$12.50 to cover one Type 200-B Variac.

Our Variacs as described in the enclosed bulletin are not automatic voltage regulators and, therefore unsuitable for ironing out fluctuations in line voltage. Our Variacs are similar in principle to the volt adjuster which you already have but are much smoother in operation since the output voltage is smoothly and continuously adjustable, but to take care of high and low line voltages a voltmeter connected across the load would be necessary. Whether the Variac would be suitable depends quite a bit on how rapidly your line voltage fluctuates.

Many photographers have solved the problem that you have by purchasing a Raytheon or Sola automatic voltage regulator. These devices keep the output voltage at very close to 115 volts on line voltages from 90 to 130. Where a load voltage other than 115 volts is required, a Variac is connected between the regulator and the load. This combination of items provides automatically regulated input voltage which can be set to any desired value by the Variac.

The Type 200-B Variac will easily handle a 150-watt enlarger bulb. Many enlargers are now equipped with 200 or 300 watt bulbs and require a larger size. We particularly recommend the Type V-5MT Variac as shown in the enclosed bulletin. This unit is ready to use as received and will handle a total load of 750 watts or more but is equally effective on lower-wattage loads. This model does not have to be wired into the circuit since it is equipped with case, cord, switch and plug receptacle. The same unit is available as a Type V-5 Variac for panel mounting but must be wired into the circuit.

Since we are not certain that the Type 200-B as ordered will meet your requirements, we are not making shipment until we have your further instructions. Prices for the models mentioned above are summarized on the attached quotation. If one of our Variac transformers is not what is required, we will immediately refund the \$12.50 already received. Your further instructions will be appreciated.
