Two requests have com to me via other organizations regarding photographs of Navaho material. One from the Museum of Navajo Ceremonial Art, and the other from the University of New Mexico.

At the present time I am personally in the midst of finishing a book on the Navho on which I have been working for some years. I hope to finish it this summer. While I have most of the material you have requested, I cannot release it at this time. However, as I expect to go out on the reservation again before long, I would be glad to make anything you may require. The request to the University for savahe rugs and silver, I could furnish either in black and white or color as the material is here in the Laboratory of anthropology. The hogans, etc would be work in the field.

My regular rate on color transparencies is \$25. ea. on 4x5. This is for as perfect a job as possible for correct color rendition. The black & white in the field would be \$15. ea for a first quality job.

I shall be happy to collaborate with you in any way possible on your work, and hope that it will be within your allotted budget.

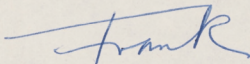
