Instructions Regarding Registration of Dogs Whelped in the United States (Be Sure Also to Read the Instructions on the Other Side of this Application)

IF YOUR DOG WAS IMPORTED, SEND FOR SPECIAL APPLICATION BLANK

1 The LITTER of which this dog is a part must be registered BEFORE the INDIVIDUAL dog may be registered. This must be done by the owner(s) of litter at birth.

2 The owner(s) of the litter at birth must insert signature and address in section 7 (other side) and if the dog is disposed of he (they) then MUST fill out section 8. The NEXT FOLLOWING OWNER(S) must complete section 9.

3 The complete chain of title is required for the records. A separate statement is required for each transfer (SEE FORMS BELOW.) If person(s) who signs line No. 9 disposes of the dog, Transfer Application No. 1 (below) should then be completed and The American Kennel Club will register and record the transfer at the same time. Transfer Application No. 2 (below) is for the next subsequent change of ownership. Should further transfers be made, additional Application forms may be had, free, upon request.

4 The name of a dog may not be changed after it has been entered in the American Kennel Club Stud Book. A Kennel Name will be recognized in connection with the ownership or breeding of a dog only when such name is registered with the A.K.C. Signed permission for the use of a registered Kennel Name must be given in space provided on other side of this Application.

5 The American Kennel Club reserves the right to cancel any Registration or Transfer enrolled through error, misrepresentation or fraud, together with any entries that may have been made for any descendants of such dogs.

6 Duplicate names are not permitted. The American Kennel Club reserves the right to assign a numbered suffix to a name which duplicates another.

HOW TO REGISTER A LITTER OF PUPPIES

1. Insert the name of the Breed of the litter; the number of male and female puppies living at the time the application is submitted; the Month, Day and Year on which the litter was born; and the City and State of birth. Any change or erasure in the number of living puppies or in the date of birth requires written verification by the Owner of the Dam on the Date of Birth of the Litter.
2. Insert the exact Registered Names and AKC Numbers of the Sire and Dam of the litter in addition to the Registered Names of the parents of each. Print this information clearly. If either the Sire or Dam is not registered, or if either of their applications is in process at our office, the registration of the litter should not be applied for until the certificate for the Sire or Dam is received by the owner so the Registered Name and AKC Number can be inserted on the Litter Application.
3. Section A must be personally signed by the Owner of the Sire on the Date of Mating, and the Month, Day and Year of the mating must be inserted by that person. Any change or erasure in the date of mating requires the written verification of the Owner of the Sire.
4. Section B must be personally signed by the Owner of the Dam on the Date of Birth of the Litter. If that person was also Owner of the Dam on the date of mating, it will not be necessary to complete any other Section with regard to the dam. The litter will be registered in the name of the person whose signature appears in this Section.
5. Section C on the reverse side of the application must be personally signed by the Owner of the Dam on the Date of Mating only in a case where ownership of the dam changed during whelp. Whether or not the actual mating was witnessed, is to be checked.
6. The fee for registering a litter of puppies is \$2.00. In all cases, the necessary fee must accompany application(s) when submitted to us.
7. PLEASE NOTE THE FOLLOWING.....
 - A - The normal period of time between dates of mating and birth of a litter is approximately 63 days. Special care should be taken to insert correct dates. (See paragraphs 1 and 3 above regarding changes or erasures.)
 - B - Personal signatures are required when called for, as printing or typing will not be accepted. If dog is registered in joint ownership, all owners should sign.
 - C - No other person may sign for a Registered Owner without a Power of Attorney or other official authorization in our files. Power of Attorney forms may be obtained from our office upon request and without charge.
 - D - Signature of the owner shown in each Section must correspond with the specimen signature in our files.
 - E - Leasing forms are available at our office to those persons who actually lease a dog for a specified period of time for stud or breeding purposes. However, one-time use of a dog for stud purposes does not necessarily constitute a lease; in such cases, the actual owner of the dog should complete Section A.
 - F - The name of the person signing any Section must be shown on our records as owner of the dog on the dates of mating or birth, as the case may be. Unless we are notified on official form of a transfer of ownership, we shall be forced to return a litter application if names appearing on it are not shown on our records as registered owners.
