REGISTRATION OF THOSE DOING BUSINESS WITH THE STATE

THE COMPLETION AND SUBMISSION OF THIS FORM TO THE STATE AGENCY OR DEPARTMENT CONSTITUTES REGISTRATION UNDER SECTION 72-16A-32 AND SECTION 72-16A-34, NMSA (SUPP. 1970) TO ALLOW PAYMENT TO BE MADE TO THOSE BUSINESSES DOING BUSINESS WITH THE STATE. Section 72-16A-30 to 72-16A-34, NMSA (Supp. 1970) requires that all persons doing business with any state agency, department or office that has authority to contract in the name of the state or make payments from state funds, must be registered with the New Mexico Bureau of Revenue. This requirement includes any person leasing property employed by the state or selling property to the state or performing service for the state.
