Just a note to keep you posted -- and tell you that the book and exhibition plans proceed now at a faster and faster clip. The book is typeset, the half-tones of the photographs are being made by our printer who is none less than Morgan & Morgan, (The Sons, Lloyd & Douglas, of Barbara Morgan... its all in the family and looks as if it will be treated as tenderly as the next grandchild). The book is complete (in design) and the whole result looks very elegant, bold and yet dignified. I have asked the publisher to provide each of you with several copies (I requested 10 each but that will probably be impossible), the cost of the book is \$25.00. It is being printed duotone and on a beautiful paper stock. It is going to be a very special book just to look at!

I would appreciate your prompt attention to anything that needs to be done.

(These may include letters, articles, old magazines, old cameras, lenses, equipment (small only), hand made books, personal pictures from the earlier days of your career. Please pack well and send insured, parcel post or registered mail for security reasons. I wish I could travel around and collect these items but as you can imagine I have long since been operating with my own funds and at a considerable sacrifice to perfect the details of this project.

It has been suggested that I find a museum grant to purchase this entire collection of your work after it has traveled for two years. In that way a selection of your work would be placed in a fine American museum, one which cares well for photographs and where the work is not buried but accessible. How do you like the idea? Don't forget that under such a grant you would be paid full value for your prints. I think it is a marvelous suggestion and with your support I will pursue the museum and the grant as soon as the book is out. The first suggestion is that of the Smith College Museum which is in Northampton, Mass. It has an excellent art collection for a college ^{which} and is well-studied within an exceptional art history curriculum. Also at Smith is the remarkable and very old Sophia Smith Collection which houses collections of memorabilia of some of the world's famous women. Anyway I am pleased at the idea and hope you will be too.

I am preparing myself to talk about your work in connection with my teaching of photography and its history. Is it possible to purchase slides of your work (your selection). If so, please let me know how to go about it (from you, your gallery, etc.)

As you probably know, I am still raising funds for this project. The tide of inflation has been very difficult to overcome. If you have any ideas of individuals who might wish to be patrons of the Exhibition please let me know. I will put them in touch with the development director at the International Center of Photography.

Any questions? I need to know as soon as you can tell me whether or not you plan to attend the opening celebration at ICP in New York on September 20th (tentative date until we know for sure whether Joan Mondale will open the show) I realize that travel is difficult but I'm hoping to see you there and, as you know, there are funds to cover your expenses for the trip. Arrangements will be made for individual needs so please tell me about them in detail (need elevator, want to have a host/hostess to chauffeur me, prefer a hotel, etc.) Whatever is on your mind, I need to know it, so that I can direct the Museum to satisfy each person's needs as much as is possible.

A final bit of news: The show which will balance Recollections in the Museum during the same time (Sept. 21 - Nov. 3) is an exhibition of work from the American women photographers of the 1890s whose photographs were assembled

in 1900.

by Frances Benjamin Johnston. It will be fascinating to see, and perhaps some of you will know the work and can provide additional information on the women. The prints are from the collections of the Library of Congress.

Finally, let me add that the last two years have been made more exciting than I would have imagined because of all I have learned from knowing you.

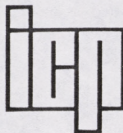

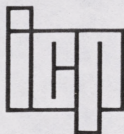
