Dear Miss Farr:-

Unfortunately I was out of town yesterday afternoon and did not get back until after the parcel post window was closed at the post office. I found the notice of a package and went down this morning to find the page proofs. Again unfortunately, my eye landed on a misspelled word, one that has gotten by all of us these many times.

I got panic stricken and fled to the Museum of New Mexico for their best proof reader who turns out to be Dr. Anderson, of the Museum staff. In going over it, he has found other things, mostly my fault and I list all the LAST corrections.

He has been working on the proofs this afternoon and will have all the rest finished to-morrow, but in the meantime I send you this first part, as far as page 99. Some of these are slight, several are important, here is the list on a separate sheet for your convenience.

From page 99 on there is not so much, chiefly wrong placing of paragraphs or lines which is quickly remedied. The second lot of pages came late this afternoon and any corrections on this will come in in to-morrow's letter also.

Now that all plans out here have been changed, I really prefer October 17th to the late September date so there is no rush to get them here by September 30th. October 10th for delivery here will be ample time. I hope you can hold these corrections for Mr. Goodwin next Tuesday.

I hope Haddon takes time to do the job right, it would be a great pity to spoil anything now with a rush. It is coming so wonderfully well. Good luck and best wishes to all.
