

Declaration and Consent

The undersigned understands that Mrs. Nell Dorr, of 1040 Park Avenue, New York, New York, is about to enter into a contract with United World Films, Inc., a Delaware corporation, for the distribution and exhibition throughout the world of the motion picture on the modern dance (produced by said Nell Dorr), at present entitled "The Singing Earth", in which the music was composed by Arthur Kleiner, the choreography was furnished by Kurt and Grace Graff, and the voice accompaniment was furnished by Hunter Galloway.

The undersigned, desiring that said motion-picture shall be exhibited, and in order to induce said Nell Dorr and said United World Films, Inc. to enter into said contract and in consideration of their doing so, hereby declares and confirms that, insofar as participation by the undersigned in the making of said motion-picture is concerned, and insofar as the undersigned may have made any contribution thereto or might have any rights in respect of said motion-picture or its distribution, use, sale or exhibition, said Nell Dorr has the sole and unencumbered ownership of said motion-picture and of all rights of whatever kind therein and in connection therewith and has the full and exclusive right and authority to grant to said United World Films, Inc. an exclusive license to release, distribute, sell, market, issue, re-issue, license, sub-license, exhibit, exploit, televise and otherwise deal in, dispose of and use in all countries and territories throughout the world, theatrically and non-theatrically, standard guage (35 mm) and narrow guage (8 mm and 16 mm) versions of said motion-picture and to grant to others all such rights; and the undersigned

hereby irrevocably consents to the granting of such exclusive license by said Nell Dorr to said United World Films, Inc. and to the carrying out by said Nell Dorr and by said United World Films, Inc. of the terms of said contract, which terms include (as more particularly set forth in said contract) the exclusive right in said United World Films, Inc. (a) to exhibit, project, perform, reproduce, and to license others to exhibit, project, perform and reproduce, said motion-picture by television and by any device or means analogous thereto, now known or hereafter devised; (b) to use the title of said motion-picture and to cut, edit, arrange, re-arrange, modify, alter, change, add to, subtract from and adapt said motion-picture, and to score, re-score, record and reproduce dialogue, language (English, or foreign), sounds, speech, music and subtitles (in any language); provided that the exercise of such rights shall be preceded when practicable by consultation with said Nell Dorr and shall preserve the artistic integrity of said motion-picture, the dialogue and the music; (c) to prepare dubbed versions of said motion picture for distribution in foreign language countries and for that purpose to prepare re-narrations in foreign languages to be synchronized with the action and dialogue of said motion-picture; or in lieu thereof, to prepare superimposed versions with foreign language sub-titles; (d) to reproduce the sound and music synchronized and recorded in and in connection with said motion-picture; (e) to record, synchronize or otherwise use said music in and in connection with said motion-picture and the distribution, exploitation, sale, exhibition and television thereof, throughout the world; and (f) to copyright said motion-picture, including music and voice accompaniment, in the name of said United World Films, Inc. and to exercise all rights as copyright owner thereof, in trust, however, for

the benefit of said Nell Dorr as provided in said contract.
