### Associated Films of YWCA - Mr. Frederick

Went to the Y. to show film - he turned out to be QUITE deaf - had an EXTREMELY worn-out machine and speaker that sounded like the original Edisona great crash in the middle of the film as one reel, which he hadn't fastened properly, fell to the floor... of course it broke and he offered to repair it, at which point being QUITE mad, I told him "thank you, no" I would take care of it...Anyway, the result of it wll was that he said this wasn't the sort of film he handled - wasn't interested and didn't think the words or music fit the film... I had our film lab technician fix the film and he did a swell job - lost only 6 frames which actually isn't much, but next time (and now there doesn't have to be a next time) I think we should refuse to show it at all on doubtful equipment.

Gainsborough Films - Mr. Rudick

I called him and his opinion was that this print was too dark for televisionpossibly he would be interested in a black and white copy for it, but only lukewarm interest...He said that has really only interested in your <u>next</u> film and would like to talk to you when you are back... My impression is that he is not of great value at the moment.

# Dance Magazine - Miss Lydia Joel - 520 West 34 St. - NYC

She came to the MOMA and we had a long talk - liked her very much and she loved the film...Nell, she wants you to do an article for her mag about the film - on the making of it - and the making of them in general - on dance in general - ideas for your new film, etc. etc. - she wants stills to illustrate with and I will write Graffs for them. I told her I would tell you to write her - so if you are interested - that is her address.

Also spoke with her at a different time - she had missed RCA and wanted to see it - asked her to come to the MOMA when showing it but she couldn't then told her to come to the YWCA where I was showing it next but she didn't make that either... however, we had a long talk, told her all about it and she will note it in the magazine also... was going to call her again and ask her to come and see it when I show the film to Brandom but that had now changed.

#### Brandom Films - Mr. Brandom

His secretary called me - said they had heard of the film and Mr. B. was interested in seeing it - that he was on the coast at the moment but was coming back this week and wanted to borrow the film for the weekend... Because of his reputation and what I have heard around, I said no to that that I would rather come with **most** it and show it to him - which was to have been yesterday (Fri.) but was then postponed to MOMday. ## UNITED WORLD - Mr. Wilson and Miss Boulkend (his assistant)

Had discussions back and forth with Miss Boulkend - arranging to see Mr. W. etc. - first time we were to meet was called off because he had been too busy to think about and hadn't decided - then another time he was sick and that appointment was postponed - then the next time he was in, he called me and we had a long talk about it and that he was definitely interested etc. and that we would meet to discuss particulars ... this was when I telegramed you for I thought that he would bring the contract with him yesterday (Fri.) when we had tea here at the MOMA - however, that is a huge book of a think and will take some days to draw up and so we just settled the terms of the contract and things in general ... he is going to meet me again the first of the coming week with the contract ... . which, by the way, is a VERY GOOD one .. in a brief talk with our Technical Director infact, he couldn't believe the whold thing and is further thunderstruck by the good deal. Briefly, it is a 50-50 contract - we divide the profits of the bookingsand they are even going to make their own copies - all we have to do is provide them with the master copy and negatives! At the very beginning, they will subtract expenses, but not more than 40% so there willxxtei(I can't type anymore ;) will still be something to divide.
