About six weeks ago when we rented a projector to show "The Dorr way" -- which incidentally was in perfect condition -- we also ran "The Singing Earth." The sound track seems to be a bit deteriorated. Ken was using the projector. He has had some experience with the use of films and thought perhaps it had dried out considerably. I believe he put some damp blotters in it later to attempt to give it some moisture. Because of the condition of the sound track, I thought it advisable to attempt to get the Museum's copy of the film.

Am I right about the pre-print materials? Miss Akermark said she also did not think there were any available. Could they be made available if the USIA thinks they need them? You might drop me a note about this in case they request them before you return.

I hope your trip is materializing as you had planned and that you are having an enjoyable time. If I can help you by doing anything here, please let me know. We have been having grey, murky weather for the past few days.
