I asked if they had costs on these and none available—but my own feeling is that on this book(which they are playing up as the forerunner of international editions) the question of your letting them take costs and thereafter taking 20% is going to be very little different, if any, on their having 50% and

paying costs. I've talked to Paul Brooks about this matter and he feels we will be better off since Sierra is indeed using Galapagos for an initial publicity item on foreign editions and if this whole cost is to be charged aginst you this isn'T good, and there seems, at this point, no reasonable or easy way of splitting matters up. At any rate it's clear to me from a monetary point of view, it's likely to be equal, and so I suggest settling for this work on their 50% arrangement-I have told Sierra that this established no precedent on future works
